Community outreach and recruitment is accomplished thru monthly coffee chats and local speaking engagements.

ADU SLO activities included 18 All-Electric Energy Efficiency Workshops, and How-To ACU SLO workshops, drawing 600+ curious and interested visitors and participants. Funding was provided by 3-C Rent and the City of Arroyo Grande.
